Childless adults with income = or <\$16,754, Parent family of 3 with income = or <\$28,677, and Person with disability with income = or <\$16,754. The previous plan used to be for only pregnant, under 19 or age 65 and up. The new coverage fills the gap for individuals not in those categories.

IV. SGCC Director's Report – Ricardo Cabellos, Director Situation :

• Friends of Southgate Community Center, Inc. received a letter of apology from NCS staff member Candice Tran, for using our FoSGCC tax exempt EIN number without prior approval, and clearing up confusion about a \$100 check sent to us from GreaterGood.org. She was helping a participant, Crystal Reyes, from Willston Computer Club house submit a video with Girls' Voices for a contest. Crystal won a \$100 stipend for participation but in order to receive the money needed to associate with a non-profit. She needs to have FoSGCC act as conduit to get money to winner. Also, stated that this will never happen again. Gerald, treasurer will deposit the \$100 check into FoSGCC account.

Highlights:

- Debbie Gibbons Weichert Realtor donated gifts for SGCC afterschool participants
- Friends of Southgate were able to collect 100's of toys from Toys for Tots in Fredericksburg, VA
- Southgate collected dozens of slightly used soccer cleats, soccer balls, and 100's of brand new soccer uniforms and sent to Santa Lucia, Honduras-Central America.
- 35 community members participated in Mental Health First Aid classes held Dec. 11-13, 2018 and was taught in Spanish.
- Community Center league Basketball games have started
- Winter camp was successful with 51 registered participants
- 6th graders partnership with Teen Center starting in February. They are aging out and are getting 'bored' with center activities.
