- Increase balance in Advisory Fund to enhance capability to support SGCC programming efforts
- ii. Have all Council members involved in a minimum of 15 hours of service at SGCC
- iii. Have all Council positions filled
- iv. Support SGCC staff to increase outreach and programming to our adult communities, especially seniors.



Highlights:

- 115 total kids registered for Summer Camp. Capacity is 100. Anticipates some absent campers daily. The camp is for rising Grade 1 Grade 6 students. Hours 8:30am 5:00pm. Capital Area Food Bank providing meals and snacks all Summer.
- Quiet Zone created to replace Time-Out, for children who need time to de-stress, relax and chill. Sensory toys, Lego wall and books will be in the area.
- 11 kids have signed up for the Teen Sup program (Step up, Speak up, Stand up). Giving back to community through service projects, and having fun along the way. Program for rising 7th and 8th graders who have aged out of camp. Only 11 students selected.
- VIP camp will have a 7:30 am pickup at Southgate to take kids to Reston Teen Center starting July 2 August 2. 8:00am 4:00pm
